Commissioner O'Sullivan,

Previous correspondence refers. We write again in specific context of our letters to you dated July 1<sup>st</sup> and August 3<sup>rd</sup> last, as well as nine letters previously sent which have either been ignored, deferred, not properly responded to – or otherwise redirected down the proverbial 'bottomless rabbit hole' at Garda HQ.

The so-called 'responses' issuing at the hand of Superintendent Frank Walsh and others at Garda HQ ostensibly 'on your behalf' are so blatantly contemptuous, contrived, evasive and calculating, that to refer to them in any other format would be an affront to decency. Reinterpreting our legitimate requests for information as 'complaints' – so they can then be redirected to a toothless GSOC (where YOU assign the Garda Investigating Officers) is a ploy that has worn far too thin Ms O'Sullivan. As Garda Commissioner, you have NO lawful excuse for NOT providing us with the information required to lodge criminal complaints and a civil action in the Courts. Redirecting our correspondence elsewhere without answering any of our questions is a clear and blatant attempt to interfere with justice. Likewise, you have NO excuse for NOT tackling the multiple instances of criminality and cover-ups by Garda Management ongoing under your watch.

We have no intention of continuing this farcical merry-go-round with supposed 'public servants' while multiple abuses of the law and the Constitution get swept under the carpet. These thinly-veiled efforts by you and your subordinates to avoid accountability for this shambolic state of affairs are not going unnoticed by the public, nor is your obvious scorn for the people whom you have solemnly sworn to 'protect and serve.' You are a citizen of this country too Ms O'Sullivan, and if you perpetrate crimes against other citizens – or in any way direct or facilitate the same – then you too may expect to be held accountable under the law.

Accordingly, and for the purposes of transparency and accountability, this letter is being copied to your private residence, along with a copy of our letter of August 3<sup>rd</sup> last, so there can be no doubt or discussion that you *personally* have been fully apprised of the situation.

We also attach a copy of the Power of Attorney letter as signed by Mr Joe Doocey so as to eliminate any further excuses you may attempt to deploy for NOT providing us with the information required to make a formal criminal complaint and take action in the Courts.

We now formally place you on Notice that any failure or refusal to furnish us with the required information within seven days, will result in you *personally* facing criminal charges in the Courts for interfering with, obstructing and/or perverting the course of justice.

Trusting the position is clear.
